To carry on the business of online retail sale and trading through ecommerce platforms, including buying, selling, reselling, importing, exporting, distributing, marketing, supplying and dealing in all kinds of goods, products, merchandise, commodities, articles and services of every nature and description including consumer goods, household products, lifestyle products, garments, textiles, footwear, accessories, electronic items, digital products, office supplies, industrial products, health and wellness products, food and nonfood items, and other permissible goods through websites, mobile applications, online marketplaces, digital platforms or any other electronic or internetbased medium.

To establish, develop, operate, maintain and manage ecommerce

platforms, online portals, digital marketplaces, mobile applications, software systems and technology platforms for facilitating the buying, selling, marketing, promotion, distribution and supply of goods and services and to provide related services including payment processing, catalog management, order processing, logistics coordination, customer support and vendor management.

3.

To carry on the business of retail trading through stalls, kiosks, exhibitions, fairs, markets, temporary shops, street vending, retail counters, outlets or other physical retail formats and to deal in all kinds of consumer goods, merchandise, products and articles of every description permissible under law.

4.

To provide business support services and business process support services including marketing services, sales promotion services, administrative assistance, outsourcing services, customer support services, vendor coordination, operational support, documentation services, consultancy, advisory and other allied business facilitation services to individuals, firms, companies, organizations and enterprises.

5.

To provide digital marketing, online promotion, advertising, branding, social media management, lead generation, customer relationship management services, data processing, content management, catalog management and other technology-enabled business support services.

6.

To act as agents, distributors, franchisees, commission agents, representatives, traders, resellers or service providers for

manufacturers, producers, traders, importers, exporters, companies, firms or service providers in India or abroad and to undertake marketing, promotion, distribution and supply of their goods and services.

7.

To undertake activities relating to import, export, sourcing, procurement, packaging, branding, warehousing, logistics management, supply chain management, distribution and delivery of goods and services related to the business of the company.

8.

To undertake all activities incidental or ancillary to the attainment of the above objects, including collaboration, partnership, joint ventures, technology partnerships and other lawful arrangements with individuals, firms, companies, organizations or institutions in India or abroad.

9.

To carry on any other business or activity which may seem to the company capable of being conveniently carried on in connection with the above objects or calculated directly or indirectly to enhance the value of or render profitable any of the company's business or property

(b) *Matters which are necessary for furtherance of the objects specified in clause 3(a) are

To acquire, purchase, lease, hire or otherwise obtain land, buildings, offices, warehouses, showrooms, shops, equipment, machinery, computers, servers, software, vehicles or other movable or immovable property required for the business of the company.

To open, operate and maintain bank accounts of all types with banks, financial institutions or other entities and to borrow, raise or secure money in such manner as the company may deem fit for the purpose of its business.

To appoint agents, distributors, franchisees, consultants,

advisors, contractors, employees or representatives for the conduct of the business of the company.

To enter into agreements, contracts, collaborations, joint ventures, partnerships or arrangements with individuals, firms, companies or organizations in India or abroad for the purpose of carrying on the business of the company.

To advertise, promote, market and publicize the products, services and business of the company through any media including digital platforms, websites, social media, print media, exhibitions, trade fairs or other promotional activities.

To apply for, obtain, register, purchase or otherwise acquire trademarks, copyrights, patents, licenses, brand names, domain names, intellectual property rights or similar rights for the benefit of the company.

4 The liability of the member(s) is limited, and this liability is limited to the amount unpaid if any, on the shares held by them.

5 Every member of the company undertakes to contribute:
